Nature of Work:

Expression of Interest (EOI) is invited for the selection of parties for the demolition of existing buildings and associated works including disposal of serviceable/unserviceable materials/debris as per Government/Statutory bodies guidelines including cleaning and levelling of the ground and handing over the peaceful possession of vacant land to AIAHL. All permission/NOC/ approvals from Government/Statutory authorities to execute the work of demolition and disposal of retrievable/unserviceable items, debris etc. are to be arranged by successful parties. The parties are advised strictly not to cut the trees as per Government guidelines.

Scope of Work:

AIAHL intends to undertake demolition of the old existing buildings at AI Housing Colony, Vasant Vihar, New Delhi. Qualified parties with prior experience, financially sound and capable to obtain all Permission/NOC/Approvals from Government/Statutory authorities, are invited to submit Expression of Interest (EOI) for execution of the demolition of existing buildings and associated work including disposal of serviceable/unserviceable materials and debris strictly as per environmental and safety norms of the Government/Statutory authorities. All the serviceable/unserviceable materials will be removed from the site and site will be cleared of all debris and ground will be leveled after demolition work is complete.

The built-up area of the buildings to be demolished is approx. 600000 sqft.

The parties will be allowed to demolish the buildings duly earmarked by AIAHL as per **Annexure-1**. The other buildings like school buildings, electric sub-station, guard huts, boundary walls etc. and all other infrastructure and properties of other authorities e.g. MCD/DJB/BSES/MTNL/IGL etc. will not be demolished.

Therefore, the parties will take prior permission from AIAHL to clearly earmark the building to be demolished before starting the demolition work.

The scope of work broadly includes but is not limited to:

1. Site assessment and preparatory works.
2. Safe demolition of existing buildings including removal and disposal of serviceable/unserviceable materials/ movable assets materials therein and barricading of the site as per Government guidelines.
3. To obtain at his own cost all Permissions/NOC/Approval from Government/Statutory bodies to execute the work of demolition of buildings.
4. Ensuring uninterrupted functioning and protecting of nearby infrastructure /services of the Govt./Statutory authorities or any other agencies during the demolition work.
5. Compliance with all safety, environmental and pollution control norms, including:
 - Dust suppression systems
 - Noise control measures
 - Worker safety & barricading
6. Collection, segregation, loading, transportation, and legal disposal of all demolition debris to authorized dumping grounds.
7. Preparation of Final Clearance & Site Handover Report.
8. To depute sufficient number of qualified and experienced civil/structure engineers & safety engineers along with other sufficient experienced staff to execute the work.

The parties will assess the tentative net value payable to AIAHL after adjusting all expenditure towards labor for demolition work, disposal and transportation/loading/unloading of serviceable/unserviceable materials/debris, cleaning/leveling of the site and including the expenditures incurred in obtaining Approvals/Permissions/NOC etc. Parties will submit indicative cost payable to AIAHL. Only eligible shortlisted parties will be issued tender documents to submit the Price Bid. Tender document containing detailed scope of work and terms/conditions along with EOI will become part of the contract.

Inspection of the Site:

Inspection of the Site is **mandatory** for the parties to understand the scope of work, quantum of work, nature of work and local site conditions to have exact hand on information of the work. No claim whatsoever in this regard will be entertained after submission of the bids. Parties are requested to visit the site and concerned buildings to evaluate the indicative price payable to AIAHL for the demolition of buildings work and get a certificate of the visit to site signed by AIAHL, on the party's letter head in the prescribed format given in the EOI. This certificate duly signed by AIAHL, will be enclosed with the EOI. **The parties who do not visit the site of work will be rejected.** The Date & Time of inspection at site can be requested through e-mail id: manager-properties@aahl.in on or before 17.01.2026 up to 1100 hrs.
